## GOVERNMENT OF INDIA MINISTRY OF RAILWAYS (RAILWAY BOARD)

### **Railway Claims Tribunal – Recruitment of Judicial Members.**

Applications are invited for filling up fifteen posts of Judicial Member in Railway Claims Tribunal against existing as well as prospective vacancies as on 31/12/2020). The selection and appointment of Judicial Members of RCT will be governed by Ministry of Finance (Deptt. of Revenue)'s Tribunal Appellate Tribunal and other Authorities (Qualifications, Experience and other Conditions of Service of Members) Rules, 2020 which was notified on 12/02/2020.

2. The likely vacancies of Judicial Members are one each at Ahmedabad, Allahabad, Bangalore, Bhubaneswar, Chennai, Delhi, Ernakulam, Gorakhpur, Guwahati-I, Guwahati-II, Kolkata, Lucknow, Mumbai, Nagpur and, Patna. It may be noted that the above vacancies are tentative and likely to be changed depending upon administrative requirements. Selected candidates are liable to be posted anywhere in India.
3. Jurisdiction : The Tribunal discharges functions in respect of settlement of disputes relating to claims for loss and damage and those relating to accident compensation against a railway administration under the Railway Act, 1989 read with Railway Claims Tribunal Act, 1987.
4. (a) Pay: The Judicial Member shall be paid a salary of Rs. 2,25,000/- and shall be entitled to draw allowances as are admissible to a Government of India Officer holding Group 'A' post carrying the same pay.  
(b) Other terms: As contained in the Tribunal, Appellate Tribunal and other Authorities (Qualifications, Experience and Other conditions of Service of Members) Rules, 2020.
- 5 (i) **QUALIFICATIONS FOR APPOINTMENT AS JUDICIAL MEMBER-**  
A person shall not be qualified for appointment as a Judicial Member, unless he,-
  - (a) is, or has been, a Judge of a High Court;
  - (b) has, for a combined period of ten years, been a District Judge and Additional District Judge.Serving officers except High Court Judges will have to take voluntary retirement from service to take up the assignment in the Tribunal.
6. TERM OF OFFICE  
The appointment will be for a period of 4 years from the date on which he enters upon his office or till he attains the age of 65 years, whichever is earlier.
7. Applications duly signed and completed by the candidate in the enclosed format should reach to Shri S.N. Jha, Under Secretary/SM/Railway Board, Room No. 211 A, Rail Bhawan, New Delhi-110001 The last date of receipt of applications in Railway Board's office is 13/07/2020. While forwarding the application through proper channel, ACRs/APARs, vigilance clearance and details of disciplinary cases etc., pending or contemplated, if any, may also be forwarded.
